

ND SBDC COVID-19 North Dakota Business Impact Survey Giveaway

The following are the Official Rules (the “Rules”) for the COVID-19 North Dakota Business Impact Survey event (“Event”).

By entering the drawing, you agree to be bound by these rules.

WHO MAY ENTER: The Drawing is open to all individuals over the age of 18 that choose to participate. Employees, officers, and directors of Sponsor and their immediate family members (spouses, siblings, parents and children) are not eligible.
